Sgt. McCroskey attended Axon/Taser Instructor re-certification in Grove City, OH. This certification will allow Sgt. McCroskey to recertify sworn personnel on the Taser 7 platform for the next 2 years.

Fire and Police crews responded to the 6000 block of Morris Road for a structure fire. Detectives and patrol officers located APRIL L. CALDWELL walking on Millikin Road and arrested her for Aggravated Arson (F1). It is reported that CALDWELL threatened to set the house on fire shortly before the fire broke out. CALDWELL was booked into the BC Jail on her charges and her case was bound over to the BC Grand Jury.

Detectives and evening shift patrol officers arrested FELIX ANTHONY NATIVIDAD-GARCIA in the parking lot of Bridgewater Falls Shopping Center after he solicited sex from a 15-year-old female via Snapchat. The Butler County Grand Jury indicted NATIVIDAD-GARCIA on (1) count of Importuning (F5). NATIVIDAD-GARCIA is out on bond and his case is pending in Butler County Common Pleas Court.

Detectives arrested and charged ALEX M. HEHER with Voyeurism (M-1) for taking photographs over the divider in the women's changing room at Kohl's on Princeton Road. Officers booked HEHER into the BC Jail and the case is pending in Butler County Area II Court. At the time of his arrest, HEHER was out on bond with an ankle GPS monitor for the same charge out of Hamilton County Courts.

Detectives charged a 15-year-old male with Pandering Obscenity Involving a Minor (F4) for receiving child pornography. Internet Crimes Against Children (ICAC) referred this case to our agency, to which detectives followed up and made the arrest.

Midnight shift officers responded to a reported reckless driver and located the vehicle on the SR4 Bypass near Princeton Rd. They observed traffic violations and stopped the driver who was found to be operating the vehicle while under the influence and was subsequently arrested for OVI.

Officers responded to the 2000 block of Allstatter Avenue for a report of a domestic in progress. The female victim stated her live-in boyfriend pushed her and beat her up by punching and kicking her in the head. A few of the victim's friends intervened before officers arrived and the subject left the area. Officers diligently searched the area for the subject and issued an arrest warrant.

Officers were dispatched to a report of public indecency around Lenox Ave / Pater Ave. Upon arrival, witnesses pointed out the suspect who had his pants down exposing his genitals and dancing. Officers detained the subject who appeared to be under the influence of drugs. The witnesses stated they were at the park with children when the subject showed up and was exposing himself, and he failed to cover himself when they told him to pull up his pants. The subject was very agitated while being transported to the jail and he was booked in for the charges of Public Indecency (F5) and Disorderly Conduct by Intoxication (M4).

Officers responded to Walmart for a shoplifter who took off running from store employees. Officers located her by a dumpster and when they attempted to arrest her, she resisted arrest. She was taken into custody and booked into the BC Jail on several charges.

Officers responded to Home Depot to locate subjects who stole property from a victim in Middletown. Officers located a male and female suspect, and the male took off running when our officers approached him. There was a brief foot chase and officers took him and the female into custody for multiple offenses, including drug charges, resisting arrest, theft, receiving stolen property, and misuse of a credit card.
