Officer Coy and Officer Caldwell attended a Bike Patrol Mobile Field Force training session at the West Chester Police Department. Mobile Field Force focuses on the knowledge and skills required to manage and control crowds and demonstrations. We appreciate WCPD for allowing our officers to join them during this training.

Officers Prater, Mahat, Fath, and Tipton graduated from the police academy with their classmates. The township was well represented at the ceremony and the officers are currently on road patrol in the field training program.

A special “Thank You” to Specialist Darrel Prewitt and all the CAPS members for a successful year at the 2024 Butler County Fair. Spec. Prewitt and the CAPS volunteers worked 110 hours at the police booth during the week-long fair.

Sgt. Miller and Sgt. Roach conducted Close-Quarter Tactics (CQT) training with the six new officers at the Ross Township training facility.

Sgt. Miller and Sgt. Roach conducted Active Threat Response Training with the entire patrol division at Cincinnati Christian Schools' Junior/Senior High Campus.

The BC Grand Jury indicted Fransisco Setik for Robbery (F3) following his arrest for pulling a [fake] gun on Loss Prevention at Walmart during a theft offense. He is incarcerated in the BC Jail pending arraignment in Common Pleas Court.

The BC Grand Jury indicted Nabin Darjee for Rape – the victim being a child under 13 years old (F1) – following an investigation by the Investigations Section. The incident occurred in mid-2022, and Darjee is incarcerated in a Pennsylvania state prison for separate offenses. A warrant was issued on the indictment and his arrest and case are pending.

Officers conducted a field stop with a pedestrian and later determined the male provided false personal identifying information. The male was arrested for obstructing official business, failure to disclose personal information, and then booked into the BC Jail.

Officers conducted a traffic stop on a vehicle driving completely off the roadway on Vinnedge Road. The male driver was arrested for OVI and for driving while under an OVI license suspension. The driver’s BAC was .341 and he had a history with two prior OVI convictions. He was booked into the BC Jail.

Officers observed a female illegally crossing SR4-Bypass on foot while intoxicated. A consent search resulted in the seizure of a bulk amount of suspected methamphetamine and an additional unknown powdery substance.

Officers responded to a dispute in the 7700 block of Wildbranch Road. While on the scene, Officers attempted to arrest a female for disorderly conduct, but she resisted arrest. Officers were able to take her into custody and they booked her into the BC Jail. One officer sustained a minor injury during this incident.

Officers responded to a robbery at El Rancho Nuevo. Employees reported that a man wearing a mask entered the business, assaulted an employee, and stole an unknown amount of money. The subject then fled the area on a bicycle. This case remains under investigation.

Officers responded to a single-vehicle motorcycle crash on SR4 near Liberty Fairfield Road. Officers arrested the male driver for OVI and determined he did not have a motorcycle endorsement. Officers located suspected drugs on him and discovered the motorcycle had a defaced VIN. The male was booked into the BC Jail.

Officers responded to Kohl's for shoplifting in progress. The suspect was found hiding inside Popeyes Chicken Restaurant. The suspect initially refused to provide his information, stating that he was Jesus Christ and rose from the dead. Officers determined the suspect's identity, and the subject had several outstanding warrants. He was booked into the BC Jail.

Officers responded to Rose Hill Cemetery for a breaking and entering report. Two suspects broke into the utility building overnight and stole tools and an F-350 truck owned by the cemetery. The truck was recovered in Hamilton shortly thereafter and this case remains under investigation.

Officers responded to the Laurels of Hamilton for a combative patient who was attacking nursing staff. Officers assisted EMS with restraining the patient to a cot and transporting him to Fort Hamilton Medical Center for a psychological evaluation.
