It was another successful year at the annual Butler County Chiefs of Police Association “Respect for Law Camp” program at Miami University. It was a hot and dry weekend, but it was still a great time. Thank you to Sgt. McCroskey, Sgt. VandeRyt, and Police Clerk Regina Leist for stepping up and helping with this year’s camp. It is not a success without the volunteers who make it happen.

Sergeant Roach provided in-service Police Jiu-Jitsu training for the police officers. This training is approved by the state and counts toward the officers’ required CPT hours for the 2024 training year.

Sergeant Miller and Officer Caldwell completed their Pepper Ball Instructor certification.

Officers conducted a traffic stop on Hamilton Middletown Road near Creekside Drive. A subsequent search of the car resulted in the officers locating a small crystal-like substance wrapped in paper and a glass paper with marijuana residue. The driver was cited for driving without a valid license, the registered owner was cited for wrongful entrustment, and there are pending charges for the drugs.

Officers responded to the 1900 block of Allstatter Avenue for a suspicious person who walked into a resident’s house and then exited. Officers checked the surrounding area and found an abandoned house with an open door across the street. Officers cleared the building and observed several hypodermic needles in a glass jar in the rear bedroom. The suspect was not located.

Officers responded to the 5300 block of Liberty-Fairfield Road for a domestic in progress. Once on the scene, officers spoke with the parties involved and subsequently arrested a male subject for Domestic Violence and Strangulation. The subject was processed and booked into the BC Jail.

Officers responded to the 7700 block of Wildbranch Road for a domestic violence call. The female victim was found to have been picked up and pinned against a wall while being choked by her boyfriend. However, she managed to escape the apartment and call 911. Officers ordered the suspect out of the residence and took him into custody. He was booked into BC Jail for Strangulation (F4) and Domestic Violence (M1).

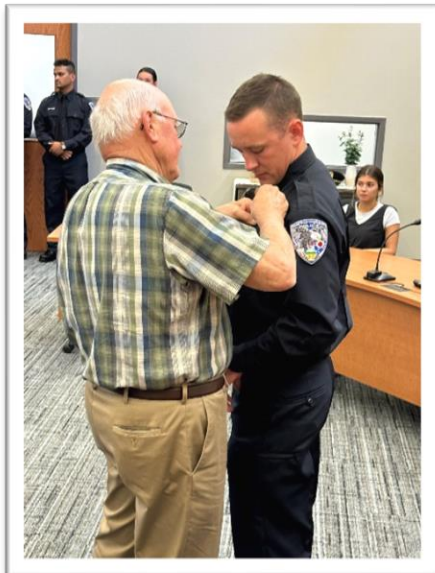
Officers responded to the 3700 block of Winter Hill Drive for a domestic violence call. Officers learned that the male suspect struck his girlfriend several times in the head. The investigation revealed that the suspect has been convicted of committing domestic violence against this same victim in other states across the country. An active protection order was in place and he was violating the order by living with her. The suspect was arrested and booked into BC Jail for Domestic Violence (F4) and Violating a Protection Order (M1).

Officers observed a male jaywalking on the wrong side of Imlay Avenue near Pater Avenue. Officers stopped the male to inform him of the violation, and during the interaction, the male became argumentative toward the officers. The male was subsequently detained and officers discovered that he had an active warrant out of Butler County. The warrant was confirmed, and the male was transported to the BC Jail.

Officers responded to Coco's Mexican Restaurant for a Breaking and Entering complaint. A suspect had broken into the restaurant overnight, pried all the cash registers open, and also made a plate of food before fleeing the scene. Evidence was collected at the scene and this case remains under investigation.
