



Fairfield Township Police Department

Monthly Report: March 2025

Sgt. Viel and Butler County Mental Health/Envision Partnership provided instruction to the Oxford Police Department staff on the Local Outreach Suicide Survivors/Drug Overdose Survivor Support Team (LOSS/DOSS) Program. The Oxford Police Department is the second police agency to implement this program, following Fairfield Township PD, which initially served as the pilot agency.

An OVI checkpoint occurred on March 24th on SR4 at Eureka Dr. The police department is a member of the Butler County OVI Task Force and partnered with them during this initiative. FTPD Officers were working saturation patrol during the checkpoint and responded to an address on Morris Road for a male driving a vehicle through the yard. The subject took off, but after a brief pursuit, the officers arrested him in Jessie's Landing. This is the subject's second OVI offense, and he has additional charges as well.

Sergeant Brandon McCroskey attended Week 1 of the Certified Law Enforcement Executive (CLEE) training. CLEE is a 14-month formal training program based on nine leadership modules. The program includes self-study, in-residence study with instructors, readings, case studies, research papers, a capstone project, and an oral presentation prior to graduating. Tuition is free thanks to a generous ODPS grant.

Sergeant Roach completed the Police Executive Leadership College (PELC) training. The three-week training takes place over three months and consists of 20 instructors, 20 required readings, four research papers, five community interviews, three team projects, and three speeches, including a final capstone presentation.

Sergeant VandeRyt attended the 2025 Police Executive Leadership College Alumni Association ("PELCAA") conference. Multiple guest speakers presented topics on current trends in law enforcement, critical incident debriefs, and legal updates.

Officer Caldwell and Officer Stebbins attended a two-day Sig Sauer Armorer course.

Multiple officers attended a 1-day training session to become operators for the new Intoximeter equipment we will receive this year.

On March 5th, detectives arrested Lenquan Conley-Beason for Rape after an investigation revealed he sexually assaulted a juvenile that he knew. A Butler County Grand Jury later indicted Lenquan on several additional counts including Rape, Gross Sexual Imposition, Unlawful Sexual Conduct with a Minor, and Sexual Imposition.

On March 8th, evening shift officers arrested a driver who passed out in his car while in the Kush Drive Thru on Tylersville Road. It was determined he was intoxicated and he was arrested for OVI.

Officers located and arrested a man who was huffing an aerosol can while parked in the Target parking lot. The subject had a decline in mental health and officers committed him to the hospital due to being concerned about his welfare. Officers acquired a warrant and arrested him on a later date and booked him into the BC Jail.
