Patrol officers began working 2025 Impaired Driving Enforcement (IDEP) & Selective Traffic Enforcement (STEP) Grants awarded by Ohio Dept. of Public Safety. In total, the Ohio Department of Public Safety approved \$60,253.20 in salary reimbursement from the state for officers to work overtime traffic enforcement details to make the roads safer in Fairfield Township.

Midnight shift officers identified a stolen vehicle along State Route 4 near Fairgrove Avenue. The occupants fled into the city of Hamilton where it crashed. The occupants of the vehicle are identified as juveniles. Charges are pending.

Midnight shift patrol arrested COLLIN ROGER LINGAR for theft after he admitted stealing between \$5,000 and \$10,000 in vinyl records from the victim, his roommate. Officers booked LINGAR into jail on 1 count of F-5 Theft and an outstanding arrest warrant.

Midnight shift patrol officers stopped an individual for a pedestrian violation in the 2000-block of Parrish Avenue. Officers arrested the individual on an outstanding Theft warrant. While doing so, officers located suspected methamphetamine which is pending lab results. Drug charges are pending.

Evening shift officers responded to Ulta Beauty in Bridgewater Falls on October 21 for a male exposing himself to females. Officers identified the male and charged him with Public Indecency. The charge is pending in Area 2 Court.

Evening shift officers arrested a mother who left her small children unattended in a vehicle while she shopped at Target in Bridgewater Falls. The mother is charged with Endangering Children. The children were released to their grandparents and Children's Services is notified of the situation.

Evening shift officers took a police report from a female victim who claims her boyfriend held her against her will and assaulted her. Officers arrested the male suspect and booked him into jail on counts of Kidnapping, Felonious Assault, GSI, and Strangulation.

Evening shift officers assisted in reuniting a non-verbal 16-year-old with his parents. He reportedly snuck out of his parents' vehicle and went into Starbucks.

Officers received training on deploying less lethal pepperballs which officers deploy using a paintball gun. All participating officers received certification to use the newly acquired asset as a less lethal option.

After a thorough investigation, the Butler County Grand Jury indicted APRIL L. CALDWELL for 2 counts of Aggravated Arson for starting a fire in her home on Morris Road on August 21, 2024. Her charges are pending in Butler County Common Pleas Court.

Multiple officers participated in vehicle CQB training at Middletown Police Shooting Range. Officers practices shooting around, in, from, and at vehicles during the training.

Day shift officers stopped a Dodge Challenger on S.R. 4 Bypass. The driver gave officers his twin brother's information to avoid detection. Officers arrested him and charged him with Obstructing Official Business and Failure to Disclose his Information.
