The township received payment for the approved body-worn camera grant totaling \$18,965.

Officers Tess Flynn and Trenton Smith attended Field Training Officer certification.

Officer Tess Flynn attended Evidence Technician Training at Miami Valley Crime Laboratory in Dayton, OH.

Ann Mayers entered a guilty plea to Aggravated Robbery (F1) with a 1-year-gun-specification for robbing AurGroup Credit Union on April 19, 2024. Mayers is scheduled to be sentenced on October 15, 2024, in Common Pleas Court.

Day shift patrol officers investigated a hit-skip crash at Speedway on Creekside Drive. Officers stopped the offending vehicle to find the driver was intoxicated with a .175 BrAC. Officers charged the driver with OVI, Failure to Maintain Control of their vehicle, and Leaving the Scene of a Crash. The case is pending in Area 2 Court.

Evening shift officers responded to the area of Milton Street for a reported shooting. Officers found a vehicle occupied by several juveniles with its windows shot out. Detectives arrested a 16-year-old-white-male on charges of Felonious Assault (X5), Having Weapons Under Disability (F3), and Tampering with Evidence (F3). Those charges are pending in Butler County Juvenile Court.

Evening shift officers arrested Shawn Burkett for a shoplifting offense at Walmart. Upon searching Shawn due to the arrest, officers found approximately 20 grams of suspected methamphetamine. Officers charged Burkett with Trafficking in Drugs (F2) and Possession of Drugs (F2) as well as misdemeanors related to the shoplifting.

Day shift officers responded to Bob Evans on Indian Meadows Drive for a male inside making threats with a gun. Officers contacted the male, seized a firearm, and charged him with Aggravated Menacing (M1).

Day shift officers located a suicidal male who jumped out of an ambulance while enroute to the hospital. The officers successfully took the male back to the hospital for treatment.

Midnight shift officers responded to a reported robbery at Speedway on Tylersville Road. Officers contacted the suspect who threatened to kill an officer and was tased. The male suspect is charged with 2 counts of Robbery, Resisting Arrest, and Obstructing Official Business.

Midnight shift officers investigated a report of stolen jewelry from a resident on Paducah Drive. Officers located the stolen jewelry in a local pawn shop with the help of detectives. Midnight shift officers arrested and charged the suspect who admitted he stole the victim's jewelry.

Midnight shift officers found, identified, and charged a reported prowler in the area of Leeds Lane. The officers conducted several nights of surveillance before finding the male juvenile suspect. Officers charged the juvenile suspect with Obstructing Official Business, Criminal Trespass, Criminal Mischief, and Possessing Criminal Tools. The charges are pending in Butler County Juvenile Court.
