## RESOLUTION APPROVING THE PURCHASE OF SHOTGUNS FOR THE POLICE DEPARTMENT FROM VANCE'S LAW ENFORCEMENT FOR A TOTAL COST OF \$14,089.00.

**WHEREAS**: The Police Chief for the year of 2025 budgeted to purchase new shotguns at a cost of \$864.35 per gun; and

WHEREAS: The purchase of the new guns is necessary for the health, safety and welfare of both Fairfield Township Police Officers and residents; and

WHEREAS: The new shot guns will be purchased out of JEDD Fund No. 2901;

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- SECTION 1: The Board hereby approves the purchase of (20) twenty new shot guns for the Police Department from Vance's Law Enforcement, at a total cost of \$14,089.00, attached hereto as Exhibit "A".
- **SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
- **SECTION 5:** This resolution shall take effect at the earliest period allowed by law.

Request to Upgrade Our 12-gauge Shotguns

Mrs. Lapensee,

We currently have a combination of Remington and Mossberg 12-gauge shotguns assigned to our personnel for less-lethal deployment. In order to increase safety, enhance officer response and reduce liability in critical incidents, it is more efficient to have one model/brand that all personnel are familiar with. Significant concerns are that the safety mechanisms, loading, sighting, etc., with two different weapon platforms can cause our officers to hesitate when time is of essence. Purchasing one weapon system minimizes this concern.

After much research, the Mossberg 590 mariner-finish shotgun with upgraded sights plus fifteen (15) Tacstar side saddles is the shotgun of choice for our usage.

Sales Representative Emma Baily, Vance's 3720 Cleveland Ave., Columbus, Ohio 43224, telephone #614-471-0712, has also provided a trade-in value of our current shotguns of \$3,060.00, which reduces the price. Vance's has also provided the state bid pricing.
