PRESENTATION – Fire fighter Jason Agoston – <u>Discussion of Patriots Day Festival</u>. We had 203 cars registered. We doubled that from last year. The Union raised \$4,000 for the Animal Friends Humane Society. In beer sales we had raised a little over a \$1,000. We made a \$500 donation to Brighton's Battalion, which is a Pediatric Cancer Foundation. We did donate \$1,000 to the overall cost of the event. The IAFF purchased a pallet of water from Walmart which we donated to the Fire Corp to sell to raise money for them and the remaining cases were donated to the Public Works Department. Next years event is on September 13th and the fundraiser for that is the Fire Buddies; a nonprofit group of firemen that give back and support kids fighting serious illness.

We also have a community appreciation night scheduled through the school. Second half of the tax settlement was received at the end of August for just over \$4M.

Mrs. Hartkemeyer - Can you let us know what the total is for curb & gutter?

Mr. McAbee – Do you have a total for the 2 events?

 $\mathbf{Mr.\ Vonderhaar}$ - The expenses were around \$30,000 and we brought in \$30,000 in sponsorship

Mr. McAbee – What about the expenses for Touch a Truck?

Mrs. Vonderhaar - I haven't gathered them yet. We did have help from Bridgewater Falls. I think the Township paid about \$1,500 for Patriots Day.

RESOLUTION AUTHORIZING BUDGET COMMISSION THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR #24-131 **Motion** made by Mrs. Hartkemeyer, second by Mr. Berding to adopt Resolution #24-131.

Mr. McAbee – We need to decide whether we're going to raise taxes or not. If we approve the rates on that sheet we're going to raise more money. I'm in favor of not raising taxes.

Mrs. Hartkemeyer – So you want to use the 2023 numbers and not the current numbers? We talked about this in June and Ms. Schultz said she was not comfortable in using old rates not reflective of our 2024 numbers.

Mrs. Vonderhaar - We cannot change the inside millage. From everything I've been told we should not mess with the tax rates. This is an annual thing and up to the will of the Board. I would proceed as the auditor requested.

Mr. McAbee - I don't think the auditor requested this. That's why we get to do it by setting the rates. We did it last year by accepting the same amount.

Mrs. Hartkemeyer - I thought we had discussed this thoroughly back in June. We had concerns about numbers that weren't reflective of our current data and there were actually some concerns about fraud. The auditor's office had concerns about the higher rates in property taxes.

Larry Barbiere, Attorney - I think this is a policy decision. Last year was the first time I've ever been involved in a discussion not to go with the numbers from the auditor. From a legal standpoint I think you could do either. It's very unusual not to go along with the decision from the auditor.

Mr. Berding - I don't consider it raising someone's taxes. We're not adding a new tax and we're not increasing the rate. We're keeping the rate the same. The economy has raised the taxes. As our expenses go up we need to collect the same rate to help offset our rising costs. I think we should keep the rate as it is.

Mrs. Hartkemeyer – We need to look at this long-term. The way that we have managed things we have made our levy last more than the 5 years it was supposed to last. I would prefer not to go for a levy anytime soon. We're doing what we normally do every single year. Last year was aberration but we're doing consistently what has been done. I think it protects our financial position to hopefully push that levy down the road.

Mr. McAbee - I strongly disagree accepting the money because we can.
